#### Professor Dame Marilyn Waring

### Professor of Public Policy, Auckland University of Technology, Auckland, New Zealand

Marilyn Waring CNZM is a New Zealand feminist, former politician, author, academic, and activist for female human rights and environmental issues.

She is best known for her 1988 book If Women Counted, and she obtained a D.Phil in political economy in 1989. Through her research and writing, she is known as the principal founder of the discipline of feminist economics. Since 2006, Waring has been a Professor of Public Policy at the Institute of Public Policy at AUT in Auckland, New Zealand, focusing on governance and public policy, political economy, gender analysis, and human rights.

She has outspokenly criticised the concept of GDP, the economic measure that became a foundation of the United Nations System of National Accounts (UNSNA) following World War II. She criticises a system which 'counts oil spills and wars as contributors to economic growth, while child-rearing and housekeeping are deemed valueless'. Her work has influenced academics, government accounting in several countries, and United Nations policies.

In 2020 Waring was appointed a Dame Companion of the New Zealand Order of Merit, for services to women and economics. In 2021 she was appointed by the World Health Organization as a member of the WHO Council on the Economics of Health For All.

#### Julie Smith

#### Honorary Associate Professor, Australian National University

Julie Smith (B Ec (Hons)/B A (Asian Studies), PhD) is an awarded Australian Research Council Future Fellow and Honorary Associate Professor at the National Centre for Epidemiology and Population Health, Australian National University. She is also a Fellow of the Tax and Transfer Policy Institute at the ANU Crawford School of Public Policy. Previously she held ARC and NHMRC funded appointments at the School of Regulation and Global Governance (Regnet), and the Australian Centre for Economic Research on Health (ACERH). Her research focuses on gender analysis, taxation policy, and economic aspects of breastfeeding, with more than 45 peer-reviewed articles, book chapters and books. She has been an expert advisor to the World Health Organization and the US Department of Health and Human Services, the Australian Department of Health, and to national and international NGOs including ACOSS, UNICEF UK, IBFAN, and WABA. She is a co-founder of WBTi Australia and a former director of the Australian Breastfeeding Association. Previously, she was a senior economist in the Australian and New Zealand treasuries and the Parliamentary Research Service in Canberra.

#### Roger Mathisen

#### Regional Director, Alive & Thrive (A&T) Southeast Asia, Vietnam

Roger Mathisen is an international nutritionist with two decades of experience working in non-governmental organizations, the UN, academic institutions, and the private sector. At A&T, he provides program and technical leadership, management, and coordination of A&T activities across Southeast Asia. Before joining A&T, Roger worked as a nutrition specialist for UNICEF in Malawi and Viet Nam. Roger is based in Hanoi, Vietnam.

#### Naomi Hull

#### WBTIAUS Coordinator, Australia

Naomi Hull is a Registered Nurse, an IBCLC and has a Masters of Public Health (nutrition) and is the Co-ordinator of the World Breastfeeding Trends Initiative Australian team. She has been a volunteer Breastfeeding Counsellor since 2006 with the Australian Breastfeeding Association and qualified as an IBCLC in 2010. During her Masters of Public Health, her interest in the 'bigger picture' grew stronger and for this reason chose to look at the implementation of the Australian National Breastfeeding Strategy (2010-2015) as the topic of her Dissertation. This then led onto her current work, which involved using the World Breastfeeding Trends initiative tool to benchmark Australia's policies and programs on infant feeding in 2018. Naomi feels strongly about finding a way to ensure the protection and fulfilment of the rights of women and children to access information and support of their health and nutrition.

#### Alessandro Iellamo

#### Independent Consultant, United Kingdom

Alessandro Iellamo is a Maternal, Infant and Young Child Feeding specialist in development and emergencies settings. He has extensive expertise in infant and young child feeding (IYCF) policies and practices, particularly in emergencies, and on the WHO International Code and other global tools. Previous engagements included working with UNICEF and WHO. He has worked with the WHO's Scientific and Technical Advisory Group (STAG) on the International Code, and has been involved in developing the World Breastfeeding Trends Initiative (WBTI) and IYCF policy tools with the International Baby Food Action Network in Asia. He has also been involved in research on IYCF policies, practices and programmes, including work environments, International Code implementation, and financial aspects of the WHO/UNICEF Global Strategy on IYCF. His expertise on IYCF and IYCF-E has supported African, Middle East and South East Asia. Recently he has been engaged with IYCF and IYCF-E related policies issues also in high income countries, like Italy, Australia and Japan. He supported emergency responses, policies and capacity building and translating the IYCF Global Strategy and the IYCF-E operational guidance into national policies, preparedness plans and training packages. He is currently representing Save the Children in the steering committee of the Infant Feeding in Emergencies Core Group (IFE Core Group), the Nutrition and Food Security and Livelihood Interagency Technical Working Group, and the Global Technical Advisory Mechanism of Information and Assessments.

#### Arun Gupta

#### Central Coordinator, Breastfeeding Promotion Network of India (BPNI)

Dr. Arun Gupta, a pediatrician in public service, founded the Breastfeeding Promotion Network of India (BPNI) in 1991. Over nearly 30 years, BPNI has played key role in strengthening national policies to promote, protect and support breastfeeding, which has led to almost negligible growth of breast-milk substitutes. He has also written extensively on child nutrition and conflicts of interest and, in 2015, convened "Nutrition Advocacy in Public Interest" (NAPi), http://www.napiindia.in/, the group works on issues like Ultra-processed foods. Dr. Gupta has worked on policy analysis related to breastfeeding and complementary feeding. Part of this work involved conceptualizing and creating IBFAN's World Breastfeeding Trends Initiative (WBTi), a break-through tool to bring together key government, academic, and NGOs to identify gaps and generate action, and created a unique web repository of policy and programmes. His strong belief in the legal frameworks

to protect public health has made significant impact in countries. Dr. Gupta coordinates BPNI and previously the South Asia part of International Baby Food Action Network (IBFAN), which is a 1998 Right Livelihood Award recipient. In 2001, the Dr. Gupta was named a Fellow of Indian Academy of Pediatrics. He is currently a member of the WHO's global development group for guidelines on complementary feeding.

#### Malvina Walsh

### Advocate for IYCF protection and support, Steering Group Member of Baby Feeding Law Group, Ireland

Malvina Walsh is a mother of 3 young children and member of the Steering Group for the Baby Feeding Law Group Ireland alliance, who advocate for the strengthening of legislation and policy to protect and support infant and young child feeding. She is a former Chairperson of BFLGI and volunteers with her local Cuidiú breastfeeding support group. She has a B.Sc. in Computer Systems and worked in the multinational corporate space for many years. She engages with influencers and decision-makers to advocate for systemic and political change.

Manisha is a public health professional with over eight years of experience in health and nutrition program design, planning, implementation, and research. The Breastfeeding Care Center of the North helps mothers with breastfeeding challenges and provides them utmost guidance and breastfeeding care like the Arugaan famous

lactation massage which helps mothers gain confidence in breastfeeding their babies. She is also an IBFAN - SEA member and a staunch protector and defender of the Code especially during the pandemic when Formula Milk companies aimed to aggressively market their products in their city during the crucial time of high cases of Covid 19. Frances has a Masters Degree in Nutrition for Global Health from LSHTM.
